



**ADMISSION TO CLASS XI - I.S.C. (YEAR 12) COURSE – 2021-2023**  
**(For Pupils of ICSE from La Martiniere College)**

All parents of pupils who were scheduled to write the ICSE examination, 2021 are hereby informed that Provisional Admission to Class 11, for the ISC Examination 2023 is commencing. This is in accordance with the guidelines provided by the Council for the Indian School Certificate Examinations (CISCE) vide Circular No. CISCE/CIR/2021 dated 19 April 2021.

The following procedure is to be adopted for admission. Please follow the instructions carefully, as personal interaction is not possible at this time.

**PROVISIONAL ADMISSION PROCESS**

1. Admission is a privilege, not a right. Students who were to write the ICSE examination from La Martiniere College **SHALL NOT BE ADMITTED AUTOMATICALLY** to **Class XI**. The Principal reserves the right to deny admission to any applicant without assigning a reason.
2. Students of La Martiniere College, Lucknow, are offered **PROVISIONAL** admission for the ISC course 2021-2023, subject to the Board Examination results as determined by the CISCE.
3. In accordance with the Fee Regulation Act 2018 The fee structure is posted on the College Website. [www.lamartinierelucknow.org](http://www.lamartinierelucknow.org) . This is reproduced below for your ready reference.

4. Transfer Certificates, by default, for all students seeking admission to La Martiniere College shall be retained by the College. Transfer Certificates for pupils who shall be seeking admission beyond La Martiniere College shall be issued upon request, after ensuring that all dues have been satisfactorily taken care of.
5. **Parents of pupils who do not apply for admission of their sons by 08 June, 2021 shall be presumed to be seeking admission elsewhere and vacancies, if any, shall be offered to other candidates.**
6. Application for Admission Forms can be downloaded against a payment of Rs 2000/- from <https://lmclko.edunify.in/class11> between **01 June 2021 from 9:00 a.m. to 08 June 2021 upto 5:00 p.m.** **ONLY.**

7. **Application for Admission Forms, complete in all respects, must be uploaded on the portal <https://lmclko.edunify.in/class11> between 01 June 2021 and 08 June 2021 by 5:00 p.m. ONLY.**
8. The **Admission Fee, Caution Money (Refundable)** and **Annual Examination Fee** are payable in full at the time of uploading the Application Form seeking admission to La Martiniere College, Lucknow. **Previously deposited Caution Money shall be refunded as per applicable rules by 15 June, 2021.**
9. For the processing of the refund of Caution Money upon the pupil's withdrawal/end of tenure in the College, a photograph of cancelled cheque for the parent's bank account is to be sent via WhatsApp to **9454469203**. **This must bear the Pupil's Name and College allotted 5 digit Personal Number written across the FRONT of the cheque. This must be completed by 08 June 2021.**
10. Upon the completion of the admission formalities an e-receipt shall be automatically generated. **The image of the receipt is to be sent via WhatsApp to 9454469203** for the Admission application to be further processed.
11. For any query, kindly use the College Office telephone numbers during working hours on working days or use the College email address. **NO QUERIES SHALL BE ANSWERED ON THIS NUMBER (9454469203).**
12. All previously recorded numbers in the Parents' Class 10 WhatsApp group of the previous session shall be converted into the **Class 11 Parents' WhatsApp Group** on 09 June, 2021. This group shall be used for sending Notices and other Instructions to parents from time to time.
13. The first module for all subjects for Class 11 through the Distance Education Programme shall be uploaded on the academic portal [lmccademics.in](http://lmccademics.in) on Thursday, **10 June 2021**. This may be accessed by the pupil by logging into the academic portal with the unique **User ID** and **Password** which was allotted to them when they were in Class 10.
14. The College offers the following subjects for study: **English** is compulsory. A candidate may choose any **four** additional subjects for study. **There is no streaming**. ANY combination of subjects of study may be selected.

#### **PAYMENT OF COMPOSITE ANNUAL FEES (PAYABLE IN MONTHLY INSTALLMENTS)**

1. The Composite Annual Fees for all pupils admitted to **CLASS XI - I.S.C. (YEAR 12) COURSE – 2021-2023** is to be deposited via the fee portal at <https://lmclko.edunify.in/fees>
2. The Composite Annual Fees (payable for ALL pupils) and the Optional Fees (additionally payable by Resident Scholars) are to be paid in monthly instalments by 15<sup>th</sup> of every month. Failure to do so shall attract a late fee of Rs 100/- per day as per rules.

**SPECIAL INSTRUCTIONS FOR PROVISIONAL ADMISSION OF RESIDENT SCHOLARS IN CLASS 11**

1. The **Admission Fee, Caution Money (Refundable)** and **Annual Examination Fee** are payable in full at the time of uploading the application form seeking re-admission to La Martiniere College, Lucknow.
2. Resident Scholars shall pay **Rs 3525/-** per month for APRIL, MAY and JUNE 2021 to cover expenses related to salary of all Domestic Staff under the head of Optional Fees. This is 33% of the optional monthly Boarding Fee usually charged.
3. Optional Fees charged at the time of admission towards **pocket money** and **imprest** for Resident Scholars shall not be charged currently, owing to the present situation. The appropriate fees shall be charged when Resident Scholars recommence their tenure in the College.
